#### **Exams:**

There will be two semester examinations and a final examination. The exams will be primarily multiple choice format, but could include short answer/essays, tax return forms, and/or comprehensive problems. We will discuss the format of each exam (breakout of multiple choice, short answer, problems, essays, etc.) during the class period prior to the exam date. The final exam is comprehensive. Each exam will include hand preparation of various tax return forms. The tentative dates for the exams are included on the tentative class schedule on the last page of this syllabus.

## Makeup exams:

Students will be expected to take examinations when given in class. If you need to miss an exam for a valid reason, you must notify me **before** the exam and will need to provide documentation for why you won't be attending the exam. The decision to allow a makeup exam will be determined on a case-by-case basis.

#### **Homework/Quizzes:**

Seven homework assignments/quizzes will be given through the semester. The homework will be completed using ConnectPlus. The quizzes will primarily include a detailed problem and/or a series of multiple-choice questions covering important topics we have covered in class. There are no makeups on homework and quizzes. If you miss a homework/quiz assignment, you will receive a zero for that homework/quiz grade. I understand that there are instances where you may not be in class or may not do well on a particular homework/quiz topic. Therefore, I will drop your lowest homework/quiz grade (or zero) for the semester. Any in-class quizzes will be announced the class period before the quiz will be administered.

Homework is very important for this class. You need to practice the concepts in order to master the skills you will need for quizzes and exams. Also, this course is cumulative in that later concepts/chapters build on the earlier concepts/chapters. Please keep up with homework, even when grades are not collected. Homework assignments and solutions will be posted on Connect or Sakai/Canvas, as assigned.

#### **Tax Return Project:**

You will **individually** complete a comprehensive individual income tax return by hand (not with tax software). Specific requirements of this project will be detailed at the time of assignment. The due date for the tax return project is noted on the class schedule.

# **Tax Return Mini-Projects:**

These will be "warm up" tax projects and exposure to specific tax forms over the course of the semester. More details will be discussed as these are assigned through the semester. The miniprojects will be 5-15 points each.

## Harvard/PwC Case Project (ACCT 613 only):

You will read, write up, and discuss a tax case during the semester. More information including purchase of the case (approximately \$10) will be provided when assigned.

#### **Attendance:**

Attendance is your choice, but your presence will significantly help you learn the material and enable you to perform well on homework, tests, and quizzes. If you miss a class, please be sure to get the material missed from a classmate. Students who attend each class score significantly higher on exams than those who do not.
